

Encompassing over 200 feet of Weiser River waterfront, this expansive 10-acre property boasts two homes in close proximity to the town of Council. Featuring two shops, more than 7 acres of pasture, fruit trees and abundant wildlife, this property offers an appealing blend of amenities and natural beauty.

Land

This property sits on 10 acres of level topography. Located 5 minutes from the town of Council, this property is an ideal balance between privacy and convenience. For the aviation enthusiast, the local airport is less than half a mile down the road. The layout of this property offers the ability to accommodate horses or cattle. There are over 7 acres of pasture that have been leased out for on average 1-2 hay cuttings a year. Depending on the water supply, over 22 tons of hay has been taken off this property in recent years.

The land here boasts a variety of fully-grown fruit trees, including apple, pear, and cherry, along with abundant raspberry bushes that yield an impressive harvest of up to 25 gallons per season.











Among the many structures on the property, there is a 31×49 ft pole barn for equipment storage and a 24×40 ft insulated workshop with propane heat and running water. By the secondary home, there is a 8×24 storage barn.

Improvements

The main dwelling is a charming home at 3,156 Sq Ft with two bedrooms and two bathrooms. Recently renovated, the kitchen underwent a complete transformation with fresh cabinets, countertops, and appliances. The unfinished basement provides boundless opportunities for an extra bedroom or storage space. Both bedrooms offer ample size, and the guest bathroom has also undergone a remodel. The water heater has recently been replaced.

The secondary dwelling is a newly remodeled 2-bedroom, 2 bathroom home at about 1,000 sqft. New cabinets and countertops were recently installed. New appliances are also included. From the porch, you have beautiful views of the Weiser River.

Each home offers their own well and septic system. Both septic tanks have recently been pumped.

The insulated shop is an exceptional space equipped with a roll-up garage door, 220V power, running water, and propane heating. The pole barn is a versatile structure featuring two roll-up doors and abundant space, making it an excellent choice for storing equipment or vehicles.

The Council area is considered the gateway to recreation in Central Idaho providing access to the Payette National Forest, the Seven Devils Mountain range, and a plethora of outdoor recreational opportunities. Some of the outdoor adventures residents and visitors enjoy include fishing, hunting, skiing, snowmobiling, camping, and hiking.


